## ORGANIZATIONAL AND LEGAL SUPPORT OF POLICE SERVICES IN UKRAINE

Paper is devoted to the research of organizational and legal provision of police services in Ukraine, the essence of the problems of legislation and normative legal acts of Ukraine, regulating the support of this activity, its strategy, main directions and tasks by law, coordination of efforts of all state bodies, primarily law enforcement, including the National Police, which realizes its tasks in the field of public-service activities that is one of the important signs of the development of a law-governed state.

The author analyzes the scientific literature and the regulations of the current legislation on the organizational and legal provision of police services in Ukraine.

It has been established that the formation of a new system of legal acts regulating law enforcement activities in the field of providing police services in Ukraine should be started with the development of the Concept of Police Law Enforcement, which should be devoted to the external administrative (police) activity of the bodies of NP in Ukraine, which occupies an important place in police law enforcement and is one of the elements of the system of central executive bodies of the state, which must apply the existing legal norms in providing police services to consumers.

The public service activity of the police as a service to serve the needs and interests of individuals and legal entities in their relations with the public administration bodies, including the police, was determined. The service itself is the result of the exercise of authority by the entity of the provision of services on the application of a natural or legal person, aimed at acquiring, changing or terminating the rights and duties of such a person.

It is specified that public service include all services provided by state bodies and bodies of local self-government or by other subjects of state power and police authorities at the expense of public funds from taxpayers.

Paper states the author's concept of police service, specifies the types of provision by the police of police services (administrative, informational, security, etc), the creation of conditions for the implementation of rights, freedoms and legal interests of a man and citizen when applying to the police for the provision of police services. It is also suggested to introduce some amendments to the current legislation of Ukraine.

**Keywords:** organizational and legal provision of police services in Ukraine, subject of providing police services, bodies of the National Police, tasks, service activities, consumer of public services, concepts and types of provision of police services.
